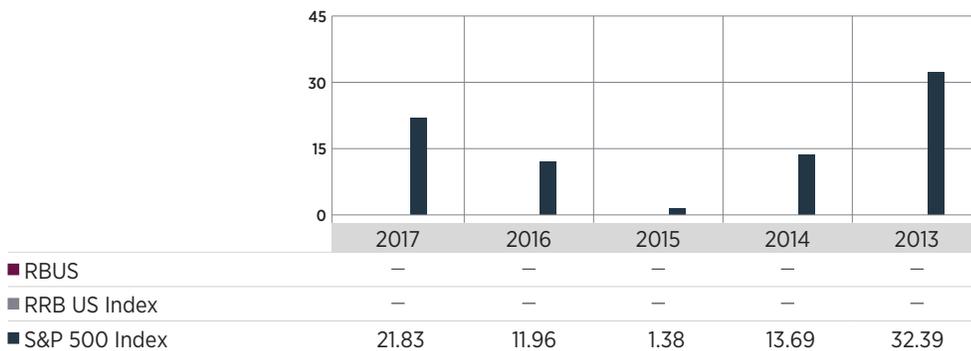

Index approach



Starts by evaluating risk

Begins with a line-by-line assessment of every security in the investable universe to determine the level of risk they represent.



Eliminates the riskiest

Eliminates the 50% of the stocks in the universe that contribute the most risk.



Equalizes the risk that remains

Weights the remaining stocks by their volatility and correlation such that each security contributes the same amount of risk to the portfolio.
