But how would your company adjust if your star talent passed away? Key person insurance can help make that transition easier.



How it works


Key person insurance can be helpful in protecting against the loss of an owner or key nonowner employees. With this plan, the business purchases life insurance on the key employee and pays the premiums. In the event of the key employee's death, the business receives the policy's death benefit to help recover lost income or to help recruit and train a replacement.



Benefits to your business

- Tax-free policy proceeds cover financial losses that may occur at the death of a key person
- Assurance of business continuity for other employees, customers and creditors
- Coverage is a business asset that enhances your business's creditworthiness for commercial borrowing
- The key person's value to your business is affirmed, strengthening the existing relationship and aiding in retention
- The policy's cash value may be available to your business through a withdrawal or loan if needed for business opportunities or retirement benefits





Meet Mia and Juanita



Their story

Mia and Juanita founded Atlantic Construction 10 years ago. When the company first started out, it consisted of the two of them and a couple of guys who worked for them as needed. Business grew over the next several years, thanks to word-of-mouth referrals from satisfied customers. What started with Mia, Juanita and a few carpenters is now a large-scale operation with approximately 500 employees throughout North Carolina, South Carolina, Georgia and Florida. At some point, they would even like to take the operation west.

Atlantic Construction has continued to grow. The senior leadership team is concerned about what would happen to the company if anything happened to Mia or Juanita. If one of them were to become ill or prematurely pass away, it would negatively impact the financial stability of the company. Although the senior leadership team has the confidence and know-how to maintain the company, they feel someone would need to be recruited to take over Mia or Juanita's role.

Mia and Juanita schedule an appointment with a financial advisor, Seth, to see if there is anything they can do now to alleviate some of these concerns for the future well-being of the company.


Their strategy

After reviewing their concerns, Seth recommends a key person insurance plan, which is commonly used to protect the viability of a business. He explains that Atlantic Construction would purchase life insurance policies on Mia and Juanita and name itself as the beneficiary. When either partner passes away, the proceeds from the policy could help keep the business going by replacing income that would be lost and providing funds to recruit and train a replacement.

After signing the life insurance application and other paperwork, Mia and Juanita take the required medical tests, and their applications are approved. When Seth delivers the policy, Mia and Juanita feel confident that Atlantic Construction would be able to survive without them.

A few things to should keep in mind

Throughout this brochure, we discuss access to money via loans and partial withdrawals.
