The Department of Labor (DOL) Fiduciary Rule broadened the definition of fiduciary advice. As a result, Nationwide is reviewing some processes, tools, and supporting activities to ensure we will continue to only provide recordkeeping, platform, selection and monitoring assistance and educational services to our plan clients.

### What you need to do

If your Plan was in compliance with the terms of the Fiduciary Warranty before June 9, 2017, the Plan may continue to rely on the terms of the Fiduciary Warranty for as long as both the Plan remains in compliance and Nationwide remains the Plan's product and service provider.
