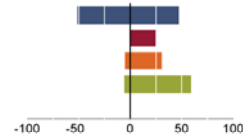

### Composition as of 05-31-24



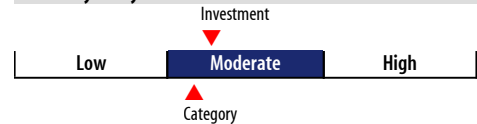

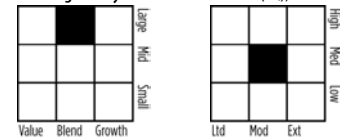
