NVIT Investor Destinations Moderately Conservative Fund — Class P

Investment Strategy from investment's prospectus

The investment seeks a high level of total return consistent with a moderately conservative level of risk. The fund is a "fund of funds" that invests primarily in affiliated mutual funds representing a variety of asset classes. It also invests in certain underlying funds that are not index funds. The fund invests a majority of its assets in underlying funds that invest in fixed-income securities, but also a considerable portion of its assets in underlying funds that invest in equity securities. It allocates approximately 60% of its net assets in bonds, approximately 25% in U.S. stocks, and approximately 15% in international stocks.

Category Description: Allocation—30% to 50% Equity

Funds in allocation categories seek to provide both income and capital appreciation by investing in multiple asset classes, including stocks, bonds, and cash. These portfolios are dominated by domestic holdings and have equity exposures between 30% and 50%.

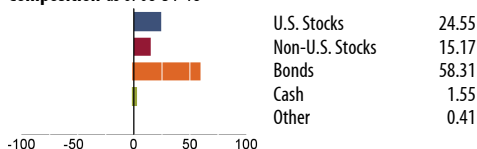

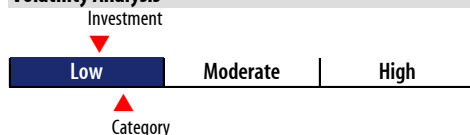
Composition as of 08-31-18

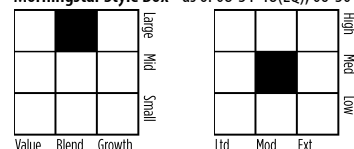
