It may invest in the securities of large, well-known companies offering prospects of long-term earnings growth. The fund may invest up to 25% of its net assets (at the time of investment) in equity securities of foreign issuers.

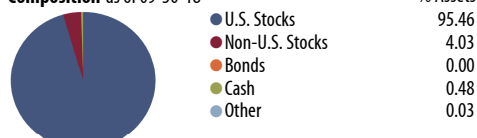

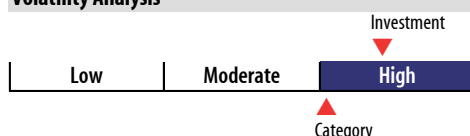
### Composition as of 09-30-18

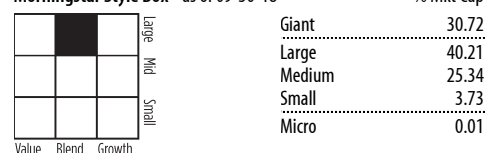
